4. Hearing of the Public

5. Action Items:

a. Approval of Parent Council Minutes, September 24, 2019

b. Approval of new Governing Board members: Kalavalli Namasivaya, Diane Ruggenbuck (appointed February 12, 2020)

6. Reports:

- a. LCAP Report and Feedback for 2020-2021. (Burke Wallace): Burke reviewed stakeholder survey results and then outlined updated goals and action items for the new Local Control Accountability Plan (LCAP), providing specifics regarding programs already in place and new supports implemented based on survey results from stakeholders. Burke provided an interactive document for Parent Council members to input their comments and suggestions live at the meeting, as well as a link to the document to provide feedback after reflection.
- b. Accountability Update (Melissa Gonzalez): Melissa provided an update on the 2019 Dashboard indicator for OGCS. Melissa reported that Ocean Grove did not have any orange or red areas, instead most in the preferred range indicating progress in many goal areas, with several state goals already met. Melissa highlighted how our interventions via LCAP funding are benefiting sub-groups and our students as a whole. She emphasized the importance of participation in state testing and announced that standardized tests are cancelled for the 2019-2020 school year due to the COVID-19 virus and shelter in place order.
- c. Curriculum Wizard (Burke Wallace). This topic was cancelled for discussion at this time.
- d. Parent Council Members' Feedback: How is the school year going? (Cynthia Rachel): Dan La Bar expressed his positive feedback about the recent IEM Family Conference. Janine Cate expressed her appreciation and positive experience with special education online therapy options. Riley Gerbrandt asked what he could do to replace service vendors that cannot operate online due to shelter in place. Cyndi Rachel suggested contacting the online curriculum library and that additional funds for shipping have been made available for parents checking out materials from the curriculum library. Cyndi also suggested beginning a list right now for next year's curriculum needs and getting the list to the ES as soon as possible. Riley mentioned that an extension to the PO deadline for current instructional funding would be very helpful given current circumstances.
